

WHAT IS A PAC?

A Political Action Committee (PAC) is used by trade associations, membership organizations, and other groups to allow individuals to pool their donations to make a larger impact on elected officials than what they could have done on their own.

WHAT IS VACUPAC?

The Virginia Credit Union Political Action Committee (VACUPAC) is the state-level, non-profit, non-partisan PAC of the Virginia Credit Union League and its affiliated credit unions.

VACUPAC funds are distributed to political candidates in the Virginia General Assembly or to other state-level elected officials who are supportive of credit unions.

VACUPAC also works with the Credit Union National Association's (CUNA) PAC, the Credit Union Legislative Action Council (CULAC), to support members of the U.S. Senate, U.S. House of Representatives and various congressional leadership funds.

WHY IS VACUPAC SO IMPORTANT?

VACUPAC funds are distributed to political candidates who champion credit unions and can help us get things done!

Your contributions to VACUPAC allow us to have a greater impact with candidates than you could make as an individual. Contributing to VACUPAC is not only a contribution in our advocacy work, it's an investment in your credit union and in your career.


